2. HOW WE USE YOUR INFORMATION:

3. WHERE WE STORE THE INFORMATION

It may also be processed by staff operating outside the EEA who works for us or for one of our suppliers. By submitting your personal data, you agree to this transfer, storing or processing. All information you provide to us is stored on our secure servers and will only be used for marketing purposes and handled by the marketing team and our approved third party tech team, Chili Sauce. 7. GOOGLE ANALYTICS

13. Employment

If Field Sport UK employs you, relevant details about you will be provided to Troy Accounts Services who provide payroll services. This will include your name, bank details, address, and date of birth, National Insurance Number and salary.

14. Your rights
